Description

Product based on standardised natural extracts of Acerola, Echinacea, Beet, Reishi and Astragalus. Due to its content in Vitamin C, B6, B12 and Zinc contributes to the normal functioning of the immune system.

40 mg, Astragalus Dry Extract (Root) (*Astragalus membranaceus Moench, ratio 5:1*) 40 mg, Beet Dry Extract (Root) (*Beta vulgaris (L.), ratio 5:1*) 40 mg, Preservative (*Potassium sorbate*) , Thickener (*Xanthan Gum*) , Echinacea Dry Extract (Root) (*Echinacea purpurea (L) ratio 10:1*) 30 mg, **Lactoferrin** (Contains milk) 25 mg, Zinc Gluconate (*Zinc 14,42%*) 20,8 mg, Reishi Dry Extract (Fruit) (*Ganoderma lucidum (Leyss. ex Fr) Karst*) 20 mg, Acid (*Citric Acid*) , Vitamin B3 (*Nicotinamide*) 8 mg, Vitamin B5 (*Calcium D-pantothenate*) 3 mg, Vitamin B2 (*Riboflavin*) 0,7 mg, Vitamin B6 (*Pyridoxine Chlorhydrate*) 0,7 mg, Vitamin B1 (*Clorhidrato de Tiamina*) 0,55 mg, Folic Acid (*Pterylomonoglutamic acid*) 100 µg, Biotin (*D-biotin*) 25 µg, Vitamin B12 (*Cyanocobalamin*) 1,25 µg

Directions

From 3 years. Take 20 ml in a single dose a day or it can be divided into two, with a 10 ml spoonful before lunch and another of the same amount before dinner. It can be taken alone or dissolved in some other liquid.

Additional Information

Used in form of Dry Extract

In our product we use dry extracts instead of pulverized plant. The extract presentation allows us to concentrate the product therefore we get the same outcome using less quantity. The dry extracts that

we have incorporated in our formulation are:

- Acerola, with a ratio of 5:1, which means that 400 mg of plant have been used to get 80 mg of our extract.
- Astragalus, with a ratio of 5:1, which means that 200 mg of plant have been used to get 40 mg of our extract.
- Beet, with a ratio of 5:1, which means that 150 mg of plant have been used to get 30 mg of our extract.
- Echinacea, with a ratio of 10:1, which means that 300 mg of plant have been used to get 30 mg of our extract.

The name "dry extract" is referred to a specific extraction process where key active ingredients are kept, and impurities and other substances without any purpose are removed. The use of dry extract has several advantages in opposition to the use of pulverized plant:

- The active ingredient content can be known precisely (standardized extract)
- The products based on plant extracts are more concentrated than those made on the basis of the total plant powder (concentrated and easy to take doses).
- Assimilation of the active ingredients alone is easier than assimilation of all compounds of a plant.

Standardized Extracts

Another important advantage in our formulation is the use of standardized extracts, which means that the plant provides active ingredients (also named plant strength) that are constant over time. In case of our product is titrated in:

- Vitamin C: 40 mg per daily dose.
- Polyphenols: 1,2 mg per daily dose.

Allergens

Our products are manufactured so that there is no contamination with any of the most common allergens, except for milk.
