### Description

Anise, Pumpkin and Gentian are very well known plants. Anise is an herb native to southwestern Asia and the eastern Mediterranean region. Anise seeds are used as flavoring agent in the food and beverage industries (bakery, confectionery, liquor manufacturing, etc). All vegetable parts of the young plant are edible. Pumpkin is native to North America. It is a rasterize plant that can grow to 10 meters long. It is a food of high nutritional value, rich in vitamin C,  $\beta$ -Carotene and Minerals, mainly Phosphorus. Gentian is native to the mountains of central and southern Europe. It is a perennial plant that can grow to 2 meters tall. The leaves are 10 to 30 cm long and 4 to 12 cm across. They are broadly lanceolate to elliptic.

## Ingredients

---

Water , Brown Cane Sugar , Anise Glycerinated Extract (*Fruit*) (*Pimpinella anisum* (L.)) 150 mg, Papaya Juice Concentrate (*Fruit*) (*Carica papaya* (L.)) 150 mg, Pumpkin Dry Extract (*Seed*) (*Cucurbita pepo* (L.)) 50 mg, Preservative (*Potassium Sorbate*) , Gentian Dry Extract (*Root*) (*Gentiana lutea* (L.)), ratio 10:1) 30 mg, Flavour (*Peach Flavour*) , Acid (*Citric Acid*) , Thickener (*Xanthan Gum*)

## Directions

---

From 3 years. Take 20 ml, two tablespoons in a single dose a day or it can be divided into two doses, a 10 ml tablespoon before lunch and another 10 ml tablespoon before dinner. It can be taken alone or dissolved in some other liquid.

## Additional Information

---

### Used in form of Dry Extract

In our product we use dry extracts instead of pulverized plant. The extract presentation allows us to concentrate the product therefore we get the same outcome using less quantity. The dry extracts that we have incorporated in our formulation are:

- Pumpkin, with a ratio of 5:1, which means that 250 mg of plant have been used to get 50 mg of our extract.

- Gentian, with a ratio of 10:1, which means that 300 mg of plant have been used to get 30 mg of our extract.

The name "dry extract" is referred to a specific extration process where key active ingredients are kept, and impurities and other sustances without any purpose are removed. The use of dry extract has several advantages in opposition to the use of pulverized plant:

- The active ingredient content can be known precisely (standarized extract)
- The products based on plant extracts are more concentrated than those made on the basis of the total plant powder (concentrated and easy to take doses).
- Assimilation of the active ingredients alone is easier than assimilation of all compounds of a plant.
