### Additional Information

#### Marine collagen is rich in amino acids

The collagen we use comes from fish. A recent study (J Agric Food Chem 55(4) 1532-1535 (2007)) has shown that collagen sourced from the sea is more easily assimilated by the body than collagen from other sources, such as collagen that comes from pig parts. Collmar contains a high proportion of glycine, proline and hydroxyproline (the most important amino acids in collagen) and other essential amino acids.

#### **Enzymatically Hydrolysed**

The collagen we use has undergone a unique process in which it is broken down into tiny fragments, so that they can be easily absorbed by the body. This process has been made through enzymatic hydrolisis. In this way we managed to break down the collagen in specific places making it easily absorbed.

#### **Pomegranate**

Even in ancient times, the pomegranate was valued for its nutritional benefits: its minerals, vitamins, fatty acids and flavonoids.

#### Presence of vitamin C

EFSA recommends the consumption of Vitamin C as it contributes to the collagen formation which is part of cartilage, bones and skin.
